### SEASONAL PARKS WORKER

GENERAL STATEMENT OF DUTIES: Performs a variety of maintenance work at County owned and controlled parks and related improvements; does related work as required.

DISTINGUISHING FEATURES OF THE CLASS: The work of this class is primarily maintenance and landscaping in nature. The work is done under the general supervision of a supervisor or other designee. The work is usually routine, but may require special skills in a trade such as electrical, carpentry, and plumbing. Custodial and/or security tasks may be required.

ADA REQUIREMENTS: This is medium work requiring the exertion of 50 pounds of force occasionally, up to 20 pounds of force frequently, and up to 10 pounds of force constantly to move objects; work requires climbing, stooping, kneeling, crouching, crawling, reaching, walking, pushing, pulling, lifting, and grasping; vocal communication is required for expressing or exchanging ideas by means of the spoken word; hearing is required to perceive information at normal spoken word levels; visual acuity is required for depth perception, color perception, peripheral vision, preparing and analyzing written or computer data, visual inspection involving small defects and/or small parts, use of measuring devices, assembly or fabrication of parts at or within arms length, operation of machines, operation of motor vehicles or equipment, determining the accuracy and thoroughness of work, and observing general surroundings and activities; the worker is subject to inside and outside environmental conditions, extreme cold, hazards, and atmospheric conditions. The worker may be exposed to blood borne pathogens and may be required to wear specialized personal protective equipment.

EXAMPLE OF WORK: (Illustrative Only)

Mow grass at County parks as assigned;  
Maintenance of grounds and landscaping of the County park properties;  
Troubleshoot and perform minor repairs to mechanical equipment;  
Paint the interior and exterior of buildings and equipment;  
Repair and clean sidewalks and other outdoor surfaces;  
Move equipment and materials as required;  
Perform custodial or security work as required.

REQUIRED KNOWLEDGE, SKILLS AND ABILITIES: Good knowledge of and skill in the methods and practices of carpentry, lawn and grounds care, painting, and other trade areas; ability to work with minimal supervision; ability to do manual labor; regular and timely attendance; and performance of duties in a safe manner.

ACCEPTABLE EXPERIENCE AND TRAINING: Completion of standard high school course work or G.E.D., with experience in the maintenance of buildings and equipment on the skilled trades level or landscaping experience; some custodial experience; or any equivalent combination of experience and training which provides the required knowledge, skills, and abilities.

ADDITIONAL REQUIREMENTS: Possession and retention of a valid motor vehicle operator's license issued by the State of Delaware. All motor vehicle violations must be reported to supervisor immediately and a good driving record is required to retain position. Must pass testing for substance abuse and criminal background investigation. Must maintain a positive work environment by acting and communicating in a manner that promotes harmonious relations with customers, co-workers, and supervisors. May be required to pass testing of physical strength and agility to qualify for and retain position. Direct deposit of pay required.
